## Membership Dues and Initiation Fee Increases

### Approved for FY 2023-2024

During the Executive Session that followed the monthly Board of Directors meeting on April 8, 2024, the Board voted to approve a 4.35% dues increase and an 11.1% increase in new member initiation fees for fiscal year 2024-2025. These modest dues and initiation fee increases are necessary for the continued fiscal health of River Bend Gun Club and they will help fund physical infrastructure upkeep and range development.

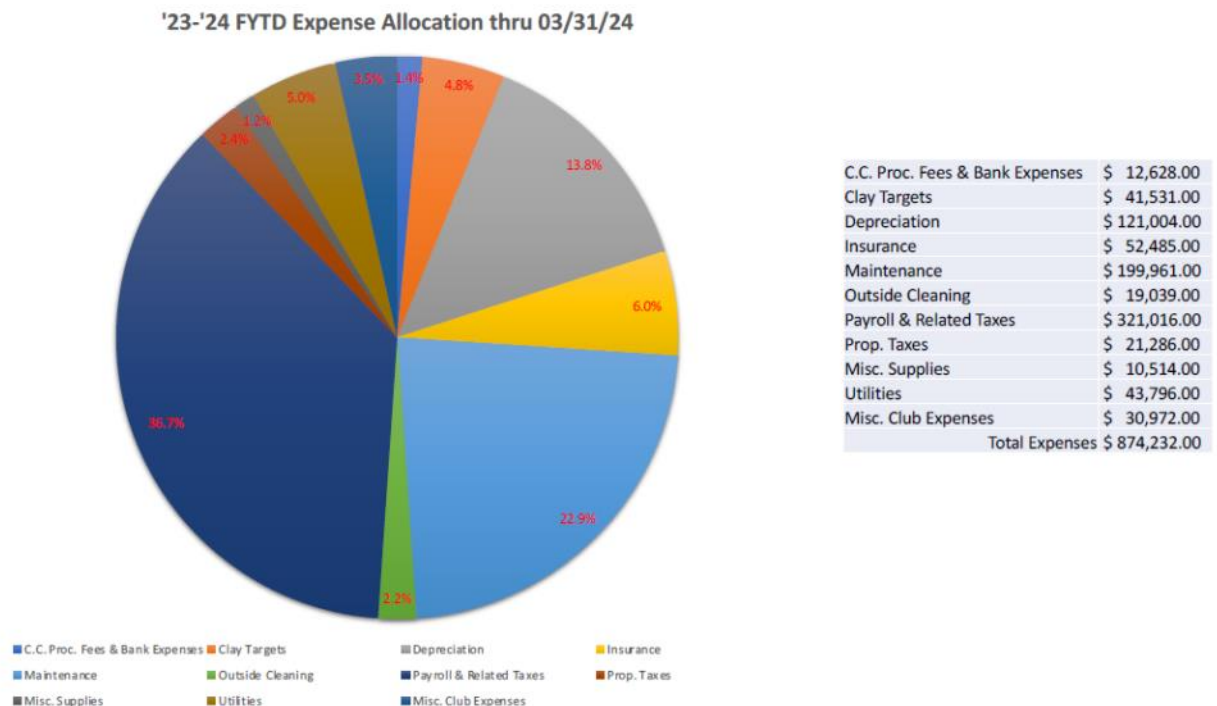
Effective July 1, 2024, dues for annual members will increase by \$15.00 to \$360 and dues for senior members will increase by \$7.50 to \$180. This 4.35% increase is consistent with dues increases in FY 23-24 (4.5%), FY 22-23 (3.8%), FY 21-22 (3.9%) and in FY 20-21 (2%). The new member initiation fee will increase by \$100 to \$1,000.

Based on current membership growth trends, the 4.35% dues increase and the 11.1% initiation fee increase for FY 24-25 will provide approximately \$51,000 in additional income from dues and initiation fee payments. Membership dues and initiation fees are the club's primary sources of revenue and, together, they generate approximately \$1,100,000 in annual income. Annual operating expenses are approximately \$900,000 and, in any given year, the club has approximately \$200,000 in "discretionary income" which is used for equipment replacement, range rehabilitation and new range development and construction.

As long as we have incremental dues increases and new member growth, RBGC will remain financially healthy and will continue to host shooting venues (matches) and provide multiple ranges for members, their families and guests to safely shoot on and enjoy. Even though the club hosts a robust match schedule on weekends, many ranges are available for member use on weekends and all ranges are generally available for member use on weekdays. The Board of Directors, Club Management the Club Treasurer and I monitor the club's financial performance closely and adjustments in spending and project time lines are made as necessary to ensure that the club remains financially solvent and debt free.

The attached pie chart shows club expenses broken down into 11 categories for the period July 1, 2023 through March 31, 2024. The club's total expenses for FY 2023-2024 were \$874,232 through March 31, 2023. As of March 31, 2023, the club had \$368,217 in the bank including \$100,224 in the Capitol Reserve Fund (to be used for unforeseen expenses like flood, fire and storm damage) and \$49,773 in the Scholarship Fund.

## Assistant Club Manager Needed

### Job Description

The Assistant Club Manager (ACM) assists the Club Manager in day-to-day operations; however, the primary role is one of membership support and lifecycle management of membership. In this role the ACM reports directly to the Club Manager and coordinates with the CRO team, Club Secretary, Treasurer, Membership Communications Manager, Range Officers, staff, members, and vendors as needed.

This is a full-time position requiring at least 40 hours per week with the requirement to be onsite at least one weekend day per month in support of New Member Orientation (NMO). Additional weekend support may be needed for special events such as the Annual Business Meeting and Picnic and the annual Young Shooters Challenge (YSC).

Candidates must possess excellent interpersonal, verbal, and written communication skills. Administrative and organizational skills are essential. # Official Club Business

## Highlights of the March 11, 2024, Regular Board of Directors Meeting

President Will Owensby presided over a quorum of seven Board members. Also attending were the Club Manager, five club officers, two annual members, two life members, two life member spouses, and one shotgun hill associate. The meeting was convened at 7:00PM on Monday, March 11, 2024. The meeting was held at RBGC's Gene Mowell Conference Center on Club property.

A quorum was confirmed, the proposed agenda was amended and adopted, the minutes of the February 12, 2024, Board meeting were approved, and the following officer and manager reports were presented and accepted:

Treasurer   Secretary   Chief Range Officer   Club Manager   Shotgun Manager

Board decisions made, actions taken, and items of interest:

- Treasurer Geoff Rhines reported that February 2024 FYTD income was \$988K, an increase of approximately \$161K versus the same period in FY 2023.
- February FYTD expense was \$810K, an increase of approximately \$107K versus the same period in FY 2023.
- Cash in the bank as of 2/29/24 was \$388,272 including \$100,233 in Capital Reserve Fund and \$49,773 in Scholarship Fund.
- Club Secretary Erica D'Amico reported that the membership total as of March 10, 2024, was 2,394; 16 members more than last month and 105 members more than this time last year.
- The number of Senior Members as of March 10, 2024, was 209, 8.73% of RBGC membership; the same number of members as last month and 3 members more than this time last year.
- There were 13 members on the Life Membership Wait List at the beginning of the March 2024 meeting.
- Chief Range Officer James Garner reported that the Range Use Summary Report for February 2024 totaled 2,206 (1,774 members and 432 guests). This is a 52.3% increase from last month, and a 4.5% decrease from the same period last year.
- Ten venues submitted Match Use Summary Reports for February 2024. Total entries were 372 (132 members, 238 non-members, and 2 juniors). February 2024 match income was \$9,097.00 with \$182.19 reported to the club.
- New Member Orientation class was held on February 25, 2024, and was fully attended.
- There were 13 Tac Rifle Certifications, 0 NFA Certifications, 0 Supergun Certifications, and 0 Stop the Bleed Certifications in February 2024.
- The Board approved Chris Sagar as Rimfire Silhouette RO and Don Coleman Rimfire Silhouette RO Emeritus.
- Club Manager Bill Goode reported that a new Kings III call box was added at AP3.
- All first aid kits have been resupplied and first aid kits have been added to all Cowboy Hill Bays.
- The renovation of the Staff House on Shotgun Hill is complete, and the room is open for meetings and members' use.
- New lights have been installed on Shotgun Hill to accommodate the League starting back up in April.
- Target backers were repaired on the shotgun patterning board and rifle ranges as needed.
- Handrails and stairs on Shotgun Hill are being repainted with fluorescent paint to aid visibility during low light conditions.
- Shotgun Hill Manager Jayde Sykes presented the Shotgun Hill report and reported that shotgun range use in February was 473 shooters (386 members and 87 guests). 1,653 rounds were fired during February with 45 cart rentals. Total February revenue to the club was \$13,319.00.
- 12-gauge and 20-gauge shells are available at \$100.00 per flat.

- Member Communications Manager David Norcross reported that the March 2024 Bullet-IN was delivered to 2,659 recipients with 2,649 successful deliveries (99.6%) on March 1, 2024. Open rate was 1,881 (71.0%) and 744 (28.1%) members clicked through the newsletter. Ten bounced and 0 unsubscribed.
- The Board approved \$34,000.00 to repair the Bullseye Pistol Range baffles at the recommendation of the Facilities Committee.
- The Board approved 11 new members.
- The Board approved \$1,400 and 2 dues certificates for door prizes for the Annual Meeting.
- Infrastructure Chairman Bill Goode reported that The Club Mapping and Tagging Project is estimated to be complete around May 1.
- Training Committee Chairman Jerry Rioux reported that the Training Expo is scheduled for September 21, 2024, in the Cowboy Hill Pavilion and Bays 7 & 8.

# 2024 MISDEEDS AND RULE VIOLATIONS BY PERSON(S) UNKNOWN

## "WALL OF SHAME"

APRIL 2024

1. Once again fellow Members, a reminder concerning where shooters must position themselves when a range or bay is marked with red stakes that delineate the rear of the firing line. The above photo is of Cowboy Hill Bay 1. The front edge of the covered seating area is seen on the lower-left of the photo, marked by an arrow and "PAVILION FRONT EDGE". This is several yards \*behind\* the red-stake makers of the firing line. Someone of our community probably used the table that is beneath the bay sign-in box as a rest or support for their rifle. Roughly two dozen 5.56 shell casings were present on the ground immediately in front of the covered pavilion. Please refer to Range Rules Section 4.1.1 – Cowboy Hill General rules, item 3 which states: **Red 4x4 marker posts and red lines of demarcation signify the rear of the bay. Any and all shooting is required forward of the red posts or demarks.**



2. RANGE EQUIPMENT. From time to time, members bring chairs, benches, steel target 'spinners' and the like to River Bend Gun Club to enjoy, and for their shooting buddies to experience. The CRO Office is delighted that our Members want their community to learn new and interesting ways to enjoy all the shooting sports the Club can accommodate. The sole caveat to this shared experience is informing the CRO Office **prior to** landing your favorite target stand, barricade –and in this case, a wooden "tank trap", on the High Power range. The representative photo below was found this week and, because no one knew who or why it was stowed on the High Power range, was removed. Typically, this type of shooting support has no place on the 600 yard range. It is more suited to PRS style matches that are definitely not shot on the High Power range.

Please let the CRO Office ([cro@rbgc.org](mailto:cro@rbgc.org)) know of, or inform the Club Manager ([clubmanager@rbgc.org](mailto:clubmanager@rbgc.org)) when you want to add to the range equipment at the Club. We are happy to work with everyone to identify the proper use for your favorite shooting range accessory, the range where it can be safely used and its storage when idle. Thank you.

3. Of concern to every Member at our great Club is the proper use of the right caliber on the right range. The white card notification you see here adorns every range sign-in box that has steel plate racks. Lately, there have been brass casings for 5.7x28 'FN' and 10mm found on plate rack ranges. As the sign says, these ammunition types are damaging to the plate racks and STRICTLY PROHIBITED. Every member of the Club needs to guard against the temptation of a 'few

rounds' and keep your range equipment in fine working condition for all to enjoy. If you have difficulty in not scratching that itch... please move to a non-steel pistol bay and blast away on paper targets to your heart's desire. Thanks again!



4. Why anyone would want to attempt a 9mm shot from the HP 300yd line is beyond any reasoning of mine. Could be the same reasoning that stopped the individual from picking up their shell casings. In any case, the Range Rule for HP range is specific: 4.7 - High-Power Rifle (HP) Range, Item 1. Firearms Permitted on this Range: Minimum caliber on this range is .222." As one might suspect, the sign-in sheet from the HP Range for the date in question did not showing anyone signing in to shoot 9mm.

## 25th Annual Rifleman's Weekend May 4th & 5th

**John C. Garand Match** for those firing the M1 Garand and M1 Carbine Rifles.

**Springfield Rifle Match** for those firing the 1903 Springfield or 1903A3 Springfield

**Vintage Military Bolt Rifle Match** for all the other bolt action rifles used during WWII, including the US Model 1917 and US Krag Rifles, but also includes foreign rifles such as the British Lee-Enfield, various German Mausers, Japanese, Swiss, and Italian rifles to name a few.

**Unlimited Garand Match** for those who have made accuracy improvements to their M1 Garands.

**Vintage Fun Match** for those with sporter versions of any of the rifles listed above (Must have iron sights). This match is run "out of competition" and is not sanctioned by the CMP. So many former military rifles have been made into sporters, and this is a way for someone with a sporter rifle to get in on the **FUN!**

The program for Saturday and Sunday is the same. You can shoot both or either day.

Sunday only, we have our version of the CMP's sniper rifle match we call the **Vintage Military Sniper Rifle Match**. The course of fire follows the same course as the other rifles, except that during the last stage, those with Sniper rifles shoot at moving targets!

We shoot on RBGC's 600 Yard Range but only from the 200 Yard line. Participants must also score for another shooter and work a relay in the target pits. If you've never been in the "pits" before, it is quite an experience with live rounds flying over your head! Many, like myself, think the pits are the best part!

The match fee is \$30 for one day and \$45 for both. Your match fee includes a Match T-Shirt, a match Patch, and a 2024-year strip. Our Match shirts are often seen at rifle competitions throughout the Southeast and the National Matches. You have probably seen our match patch and year strips on shooting jackets at the club.

You will also meet some new people and likely make a friend or two. It is a competition, and we keep score, but the point of the match is to get out, shoot and enjoy yourself. We don't compromise on safety, but we do emphasize the fun!

## NRA Light Rifle

Ah, typical April weather in Atlanta, warm and pleasant leading up to match day, then 32 degrees on Saturday greeting the first NRA Light Rifle match of the River Bend season. Fourteen hardy shooters were on hand for the fun including two new competitors.

After the safety briefing and review of the match procedures, contestants moved to the firing line with Don Coleman returning to serve as Chief Range Officer. A 15-minute practice period began at 9:30 under blue skies and little to no wind. After the practice, the first record targets were hung, and the match firing began. With Don back in the big chair, and competitors scoring targets, Match Director Simon Bailey and ARO Chris Sagar could compete with a lot less pressure.



While cold temperatures are tough on the hands and feet, there is one advantage that you get over warm weather; you can wear an appropriate jacket or sweatshirt. In addition to keeping you toasty, this layer helps dampen your pulse and body motion which provides just a tad less wobble of the sights over the target. Unfortunately, it can't help with concentration, nerves, and muscles. Still any port in the storm is welcome!

The rest during the off season had certainly done no harm, as scores of 90 and above were plentiful. King Stracke started out strong with a 93-0X while Bailey put up a 91-1X, George Wilson posted a 91-

0X and Bob Morris fired a 90-0X. Both newcomers, Josh Randall and Ron Deter did very well with Randall firing an 86-0X and Deter an 87-0X.

The second stage saw more strong scores. Brad Reynolds and Deter shot 94's with Brad adding an X. Bailey, Morris and Angelina Lemley all fired 92's with Lemley posting an X. At the end of two, Bailey, with a 183-1X, held the lead by one point over Reynolds and Wilson who separated only by the X count. Deter was one point back at 1st Master at 181 while Stracke held 1st Sharpshooter with a 180-00 and Lemley was 1st Marksman at 178-01.

The third and fourth stages saw Bailey post a 94 and a 91 to improve his lead to four points over the new second place Deter who fired a 93 and a 90. George Wilson moved to third place by firing a 91 and a 93, just one point behind Deter. Randall continued to shoot well firing a 93 in the third stage matched by Reynolds in Sharpshooter which moved him into 1st Sharpshooter after four.



In the Marksman class, Lemley continued to shoot well but dropped a few points to allow a solid performance by Glen Hegwood to close the gap, leaving her ahead by only 1X at 343-1X over Hegwood's 343-0X.

By the 5th stage the wind had picked up and so, slightly, had the temperatures. At 50 feet, the wind has a very small effect on the bullet, but it can sure push the shooter around. Careful timing and patience are major assets in these conditions with some affected more than others.

By the 5th stage Bailey's lack of offseason practice started to tell as the beginnings of fatigue led to lapses in concentration and lower scores. Posting an 86 and an 87 in the last two stages seemed like a good way to lose the match lead.

On the other hand, Wilson's patience came to the fore with an 87 and a 90-1X postings. Deter also had a slight lapse on the 5th card firing an 81, but he attempted to redeem himself in the final stage with a match high 95 – a great target indeed. To say this was a close match was an understatement.



With all shots fired, Bailey had managed to stay ahead and take first place by one point posting a 541-1X. Wilson and Deter were separated by only 1X fired by Wilson in the sixth stage! Wilson took second with a 540-1X over first time shooter Deter's 540-0X.

Brad Reynolds took 1st Sharpshooter just one point off the leader board with a 539-2X and Lemley finished strong ending on a 90 to post a final 521-1X.

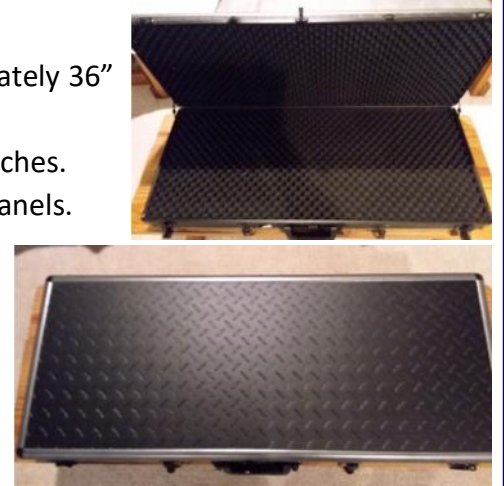
