Happy New Year 2022!

The year of our Lord, 2022 looks like it will be a good year for River Bend Gun Club. As of November 30, 2021, the club is fiscally sound with \$334,945 in the bank, including \$100,210 in the Capitol Reserve Fund. The club has a robust membership with 2,152 members and prospective new members participating in every New Member Orientation on the fourth Sunday of each month. Participation in most club shooting venues has improved slightly from where it was in late 2020 and general member use of club ranges and facilities is increasing. Even so, club members easily find ranges to use on weekdays and weekends.

On Sunday, May 15, 2022, the club will hold its Annual Business Meeting, elections, picnic and swap meet and I am excited about the picnic and swap meet. Due to COVID restrictions and concerns, the annual picnic was canceled in 2020 and in 2021. The plan for this year is to host a robust picnic with plenty of BBQ pork, chicken and beef, many tasty side dishes and dessert and I encourage all club members to attend. After two years without the picnic and the chance for members to come together, its high time we resurrect this time honored, club tradition and join one another for the festivities.

During the Annual Business Meeting, club members will elect a Club President, two Life Directors and one Annual Director. All qualified candidates must submit their RBGC Candidate Application form (covered elsewhere in this issue) to the Club Secretary by 5:00 PM on February 1, 2022. Submitted applications will be reviewed and approved during a special session of the Board Application Review Committee in February and approved candidates will be announced in the April and May issues of the Bullet-In. Please do get involved in the annual election, read the candidate statements in the Bullet-In and vote for the candidates of your choice in the annual election. If you are unable to be present to vote in person, please assign your proxy to another club member who will be present and can vote for you.

Although the club held a scaled down swap meet on August 30, 2020, we didn't have one in 2021. The swap meet is another opportunity for club members to come together to buy and sell all things firearms related, to catch up with old friends and to swap stories. Who knows? You may find that special thing you've been looking for or maybe something else that you didn't realize you really need.

The Board of Directors approved several projects during calendar year 2021. The paving of the access roads to Cowboy Hill, the Jim Hinkle Rimfire Rifle Range, the Ken Smith Bullseye Pistol Range and the Rifle Silhouette Range is greatly appreciated by club members. Although the paving projects represent a significant investment in club infrastructure, other projects completed are too many to list here. get done and all future projects are contingent on changing priorities and available budget. However, the Board of Directors and I are fully committed to doing everything we can to continue to make improvements that enhance club ranges and facilities for club member use.

- Put one or two conex storage containers adjacent to Action Shooting Complex bay 5 to support the Action Pistol, ICORE and 3 Gun venues.
- Build a covered pavilion between the buildings at Action Shooting Complex bay 3.
- Develop and activate the MP3 Rifle Range adjacent to the Ken Smith Bullseye Pistol Range.
- Continue to upgrade and improve the High Power Range.
- Evaluate the conservation status and determine the best uses for the 55 acres purchased in 2018.
- Explore locations for a club house and training facility with conference rooms and offices and begin financial planning for this investment.

Please add two New Year's Resolutions to your list for 2022.

1. Review the RBGC Range Rules sections for the ranges you use or would like to use and read Section 7. Emergency Procedures. There are too many Range Rule violations when members or guests say, "I didn't know this was against the rules." On Thanksgiving weekend, the guest of a member did a half magazine dump, rapid fire with a binary trigger equipped AR style rifle on the Rifle Silhouette Range. Of course, this attracted the attention of one of our ACRO's who went to investigate why someone was shooting what sounded like full auto on that range. When asked about it, the member said, "I didn't know my guest was going to shoot rapid fire and I don't even know what a binary trigger is." When using firearms, there is no excuse for not knowing the important things like how the gun works and what the rules are for the range being used. "I didn't know." Is a poor excuse. Please be responsible, make sure you know the Range Rules and ensure that you, your family members and guests follow them at RBGC.
2. For those club members who use the club regularly, please get involved. Become active in scheduled shooting matches, take advantage of training opportunities offered at the club, attend a New Member Orientation if you haven't attended one in the past few years, attend a monthly Board of Directors meeting or seek other ways to become more involved with the club. RBGC is one of the best gun clubs in the country because of the efforts of a handful of club member volunteers. The value club members receive for their small annual dues is tremendous and is due in large part to the few who volunteer. RBGC is a special place. Let's do everything we can to help one another keep it this way.

Training Opportunity

Hello and Happy New Year 2022 River Bend Gun Club!!

What better way to start off the new year than with pointers from a two-time USPSA National Champion? **Mason Lane** will be conducting class at River Bend this February to share the skills and drills he's used personally to improve. The training will be separated into two classes.

The first is **Gunskills 101 (Feb 18/19 - \$585)**. Don't be misled by the course title, the content in this course isn't "easy" or "basic" it's just the most important stuff. This lab and field type course uses drills to hone fundamental shooting skills, and USPSA stages to apply principles learned in class. If you are a competitive shooter of any level, or are just looking to explore performance pistol training, this course is an excellent choice for you.

- Trigger control/ Practical marksmanship
- Grip and recoil control
- Target Transitions
- Movement skills fundamentals
- Visualization/developing a mental system
- Practical integration of skills in a stage setting

The second is **Gunskills 102 (Feb 20/21 - \$585)**. This class digs into the fine aspects of understanding and developing your own shooting. Most of the content here is more about studying shooting than training individual skills. If you are an experienced practical shooter looking to improve your game, this is the course for you.

- Types of training
- Developing a practice plan
- Maximizing Shooting on the move
- Modulating effort based on circumstance
- Visualization

Both classes are two full (8 hour) days of coaching on CB-1 and CB-2 with a break for lunch. Lots of shooting and learning where your breaking points are. Estimated round count for each class is 1500.

Club Manager Needed

River Bend Gun Club is seeking a Club Manager to assume management of daily club operations within the next six months. Bill Illg, our current Club Manager since May 2018 has done and continues to do an outstanding job. Mr. Illg plans to retire in May 2022 and the Board of Directors and I are beginning the search for a Club Manager to succeed Mr. Illg now.

The Club Manager plays a key role in overseeing the daily operation of the club and they also serve as an equal member of the Club Management Team that is comprised of the Club President, the Club Manager and the CRO. The Board of Directors is also an integral part of Club Management and the Board is the ultimate authority for the management and allocation of the club's financial resources. While the Board of Directors meets monthly, the Club President, Club Manager and CRO are the most active members of the Club Management Team, they meet weekly and communicate almost daily.

Pursuant to the River Bend Gun Club, Inc. By-Laws, Article XI – Powers of the Board of Directors, Section G.

“The Board may create the position of manager, and such assistant managers as it may deem necessary for the proper and successful operation of the Club, and shall determine their duties, responsibilities and compensation. Such manager shall, subject to the overall supervision of the Board, have general responsibility for the operation, maintenance, preservation, and supervision of all Club operations and improvements excepting shooting activities and duties and responsibilities otherwise allocated or assigned in the By-Laws. He shall have authority to employ such persons or entities on a full- or part-time basis as may be required to accomplish Club operations, their duties, authority, and the compensation to be paid therefor. He shall have authority to enter into contracts and incur bills up to a limit determined by the Board annually, but shall be required to secure approval of the Board or Executive Committee for expenditures in excess of such amount. He shall make a monthly report to the Board of all his activities, Club properties, income and expenditures, and shall be subject to the supervision and direction of the Board. He shall have no authority over any officers as created under these By-Laws, but shall provide assistance to such officers and shall be responsible for performance of such maintenance of the various ranges as the range officers and Range Committee may request. Assistant managers shall be charged with the same responsibilities, but shall have no authority except such as the Board shall specifically approve. [Amended 10-08-2012]”

In addition to managing the daily operations of the club and supervision of multiple direct reports, the Club Manager also serves as Chairman of the Membership Committee and as Chairman of the Infrastructure Committee.

The Club Manager position at River Bend Gun Club is a full-time, salaried position requiring a minimum of 40 hours weekly and requiring the Club Manager to be on site at the club at least one weekend monthly. Bill Illg is a talented manager and his dedication to the club is beyond question. It is imperative that the club finds a well-qualified club member who is equally dedicated and who is highly motivated to serve as Club Manager. This is why we are beginning the search for a Club Manager early. Ideally, we seek to hire a highly qualified candidate early so that this person will be able to work with Mr. Illg and with Greg Hughes, Assistant Club Manager learning the job for a reasonable period prior to Mr. Illg's retirement.

Minimum qualifications for the RBGC Club Manager position follow:

- ◆ Must be an RBGC member in good standing for at least three years
- ◆ Must have prior experience managing multiple direct reports
- ◆ Must be proficient in Microsoft Word, Excel, Power Point and computer-based data management, accounting and communication systems
- ◆ Must possess excellent organizational skills and be results oriented
- ◆ Must possess well developed inter personal skills and public speaking ability
- ◆ Must possess well rounded management skills that allow independent decision making and also enable them to work effectively as a member of a team
- ◆ Must provide a detailed resume of employment, education and firearms related experience and training

River Bend Gun Club is one of the best gun clubs in the country, it is a wonderful place for members, their families and friends to pursue the shooting sports, compete, socialize and enjoy the natural, North GA woodland habitat. In order to help maintain the club's high standards, we need the right person for the Club Manager position.

Official Club Business

Highlights of the November 8, 2021 Board of Directors Meeting

President Will Owensby presided over a quorum of seven Board members. Also attending were three club officers, the Club Manager, and the Assistant Club Manager. The meeting was convened at 7:00PM on Monday, November 8, 2021. The meeting was held at RBGC's Gene Mowell Conference Center on club property.

A quorum was confirmed, the proposed agenda was adopted, the minutes of the October 11, 2021, Board meeting were approved, and the following officer and manager reports were presented and accepted:

Treasurer Secretary Chief Range Officer Club Manager Shotgun Manager

Board decisions made, actions taken, and items of interest:

- Treasurer Geoff Rhines reported that October FYTD income was \$690K, an increase of approximately \$8K versus the same period in FY 2020.
- October FYTD expense was \$409K, an increase of approximately \$99K versus the same period in FY 2020.
- Cash in the bank as of 10/31/21 was \$399,869 including \$100,210 in Capital Reserve Fund.
- Club Secretary Erica D'Amico reported that the membership total at the beginning of the November 2021 meeting was 2,137.
- The number of Senior Members in November 2021 was 191 (8.9% of RBGC membership).
- There are currently 11 members on the Life Membership Wait List.
- Chief Range Officer Jim Garner reported that 18 of 20 venues submitted Match Use Summary Reports for October. Total entries were 479 (255 members, 206 non-members, and 18 juniors). October match income was \$8,390.00 with \$1,274.87 reported to the club.
- Range Use Summary Report for October totaled 1,452 (1,183 members and 269 guests).
- There was a New Member Orientation (NMO) class held on October 24 for 17 of the 19 registered attendees.
- There were 7 Tac Rifle Certifications, 0 NFA Certifications, and 0 Supergun Certifications in October.
- The board approved the 2022 Calendar.
- Club Manager Bill Illg reported that the Shotgun Hill floor is now completely installed.
- The shelter/wait area at the gate has been completed.
- Kings III upgraded the Emergency phone on Cowboy Hill.
- Two Kings III Emergency boxes were ordered: one for the Ken Smith Bullseye Pistol Range and one for the Jim Hinkle Rimfire Rifle Range.
- Three heavy duty rocking chairs were placed on the Trap Range.
- An "Hours of Operation" sign was installed at the gate.
- Steel for 3-Gun was delivered.
- Shotgun Hill Manager Bill Wettingfeld reported that shotgun range use in October was 420 shooters (376 members and 44 guests). 1,361 rounds were fired during the month with 28 cart rentals. Total October revenue to the club was \$8,986.
- The Board approved 11 new members and 0 reinstatements.
- Bill Goode reported on behalf of the CRO that the Annual Range Committee meeting was held on October 31. Twenty-three Match Directors and Primary ROs attended with all venues represented. The 2022 Venue Event Calendar was reviewed. David Norcross reviewed features of the Club Express website.
- Will Owensby reported that the Young Shooters Challenge was a success. 82 of the 120 registered participants attended. Overall cost of the event was \$4,521.36.
- Infrastructure Committee Chairman Bill Illg reported that 6 concrete pads were poured: AP4, AP5, Rimfire Plinking, Centerfire Plinking 1 & 2, and near the flagpole for the shelter.
- Paving was completed for the Jim Hinkle Rimfire Rifle Range driveway, the Ken Smith Bullseye Pistol driveway, and the driveway to Silhouette, as well as the area behind the firing line.

- A 12' x 14' cover was built over the 10' x 12' pad near the message board and flag pole.
- Public Relations Committee Chairman David Norcross reported that the November Bullet-IN reached 2,159 recipients. Open rate was 1,288 (59.6%) and 603 (28%) of members clicked through the newsletter.
- Scholarship Committee Chairman Ernie Knoche reported that the scholarship applications will be uploaded in the next two weeks.

Regular monthly Board meetings are called to order at 7:00 PM on the second Monday of each month in the Gene Mowell Conference Center. RBGC members and families are cordially invited to attend.

2021 Atlanta Arms USPSA Georgia State Championship

About an hour north of Atlanta, set on nearly 400 acres of wooded rolling hills in Dawson County, Ga, is the River Bend Gun Club. The range is bordered by the Etowha River and has covered pistol bays, action and silhouette ranges, as well as multipurpose rifle, plinking, big bore, shotgun and a 600-yard high power range. Match Director Randy Gamble and his staff set out with three goals:

- Fun and challenging stages.
- Half-day format with all stages shot in approximately four hours.
- Happy staff.



They set out to accomplish this by doing certain things to ensure they met their goals. The two biggest goals were smaller squads and more staff on each stage. Georgia State has staff reset the stages instead of the common practice of competitor reset; they were able to do this by having four or five staff on each of the 10 stages. The squads were limited in size in order to accommodate the half-day schedule and keep the match on time.

The stages were designed to be challenging but nothing over the top with props and that every level of competitor would be able to take on the task. Randy Gamble designed most of the stages, while Brad Griffin helped with getting the stages on the ground. Two-hundred and sixty-nine competitors took on the 10 stages that made up the match requiring 260 rounds at a minimum. The breakdown was 105 competitors in Carry Optics, followed by 49 Open shooters and 43 in PCC. The iron sight divisions had 36 competitors in Limited, 24 in Production and seven in Single Stack, while Revolver had three and L10 with two shooters.



Stage 1, “More Human Than Human,” had the longest shots required in the match. This 26-round, 130-point stage had 12 IPSC targets and two mini-poppers ranging from close three-yard targets to long 30-yard cardboard targets that were only available from the far-left start position. The shooting area was an inverted “T” shape that required hitting your spots to engage the downrange targets before working your way downrange with some hard left to right transitions to work through and not miss on the mini-poppers. Brantley Merriam didn’t have the fastest time in Carry Optics at 17.04 but managed a stage win here with only four C’s.

Randy Gamble’s Stage 2, “Blue Monday,” was appropriately named, with its two fast-moving activated swingers, one of the only two stages with activated targets. This 27-round stage had 12 IPSC targets and three mini-poppers. There were several options on how to tackle this stage, even the “start anywhere” in the shooting area. Almost all shooters started on the left back corner to take the first outside left target before moving right to the port in order to engage a group of targets laid out in a near to far type of array, followed by a quick side-step to the right to catch a longer downrange target prior to leaving the side of the stage. At this point, competitors had to decide to either go forward, taking the steel to activate the swingers, or move to the far right for the three tucked-away targets. Some activated the swingers and then moved right, with the plan to move forward to hopefully catch the activated targets when they had slowed down. Others moved directly forward, taking the poppers to activate the swingers, then moved back uprange to the far-right position. You could also work your way across the middle of the stage, breaking up the engagement of the poppers and swingers and avoiding moving forward then having to retreat back up range. Open division saw Michael Garro’s 16.17-second run take the stage win over Christian Sailer and KC Eusebio. In addition, Rob Romero took the stage win in PCC on this stage with an 18.51-second run.

“Even Flow”, Stage 3, designed by Carlton Jones, was a 22-round, 110-point stage that made perfect use of the narrower bay it was set in. A “start anywhere in the shooting area” had about a 50/50 split on either the back left or right side of the shooting area. The left side had a target tucked back against the vision barrier down range with a no-shoot target, and another obscured by a barrel stack. The right side would have you drawing into a “tuxedo” IPSC target for your first shots. The downrange vision barriers were broken into two small openings, one in the middle and the other to right. The middle position had targets spread out that were going to make you work across the back of the bay, engaging them from the center opening. Targets were close enough to suck you into shooting too fast and dropping points on the IPSC scoring zones. Paul Kerr took a stage win here over John Browning in Limited with a 10.33-second run, compared to Browning’s 11.01. Both shot the same points.

Stage 5, “Lateralus,” was the other stage that had activated targets on it, but they were disappearing. This 24-round stage with nine IPSC targets and two mini-poppers scored the best two hits, except on those disappearing targets, where it was best four hits. This is an interesting way to make those disappearing targets worth engaging; otherwise, you are giving up 40 points on a 120-point stage. John Browning took the stage win here over Kerr, getting seven of his eight hits on the disappearing targets. Additionally, Christian Sailer nailed all eight of the hits in 12.62 seconds in Open.

Stage 6, “I Wanna Be Sedated,” was full of options for the shooters, but no matter where you started you were going to have to retreat in this 130-point, 26-round stage with all cardboard targets. The start was anywhere in the shooting area and there were four downrange positions that you were going to have work your way out of, retreating back uprange as you worked your way through the stage. Tight shots, along with two ports and targets obscured by barrels on both sides of the bay, made this a tricky stage. Trace Decker took a stage win on this course in Carry Optics in 20.11 seconds with only three Cs for a stage win. With his impressive 20.74-second run in Production, Tyler Meisenheimer won the stage.

Stage 8, “Living In Another World,” had a “toes on marks” start centered upon the uprange vision barrier. Twenty-six rounds and all cardboard targets required you to work, moving forward and retreating back to move up the opposite side, depending on which way you went on the start. Again, there were several tight shots with targets stuck back behind barrels and tough angles created by ports and vision barriers. The stage, like many of them, required you to hit your positions in order to not skip over a target. With a 14.77-second run in Open, Kyle Leite won the stage, and Hernan Delgado grabbed a stage in here in PCC.

This was the first time I have had the opportunity to shoot at the River Bend Gun Club and I really enjoyed the range and the match. They did an excellent job of putting 10 fun and challenging stages on the ground for the competitors. Using all IPSC targets puts a premium on accuracy, especially for minor-scoring divisions. The stage designs pushed competitors, gave them many options and tested shooting skills over anything else. Keep an eye out for 2022 Georgia State USPSA Championship announcements for the location and time.
