

**8th Blue Ridge Regional Team Match**

**EIC Match**  
**April 14-15 2012**

**Place:** River Bend Gun Club, Dawsonville, Ga.

**Rules:** CMP and NRA Rules will apply.

**Registration:** No pre-registration

**Ammunition:** Competitors will furnish their own ammunition.

**Empty chamber indicator:** ALL competitors will use an empty chamber indicator at all times except when firing or in the designated preparation periods.

**Scoring** 2011 NRA scoring rules will be observed both days.

**Saturday, April 14 2012**

**Blue Ridge 4 Man Team Match**

**Time:** Entries accepted until 0845, firing begins at 0900

**Entry fee:** Team Card - \$60 cash only – includes range and sanction fees

**Course of fire:** Two relays, relay one will shoot back to 300, there will be a pit change, relay two will shoot all the way back, pit change, and relay one will shoot 600. 50-Shot National Match Course, 2 sighting shots per shooter at each position, slow fire pair firing requested but not required. Pickup teams available, everyone will get to shoot.

**Awards:** Cash awards for teams,

**Sunday, April 15 2012**

**CMP EIC Service Rifle and Directors Match**

**Time:** Trigger weigh will begin at 0800 and closes at 0845. Firing begins at 0900.

**Entry fee:** \$20 Cash only

**Eligibility:** CMP Rules 4.1, 4.6.2, 4.6.3 apply.

**Course of fire:** The National Match Course, 50 shot, no sighting shots. CMP Rule 8.8.1

All competitors must score and pull pits.

**Awards:** All awards in the EIC match will be issued by the CMP. Rule 10.12.5

**Rifles:** EIC match - U.S. M1 Rifle; or U.S. M1 Rifle 7.62; U.S. M14 Rifle; or U.S. M16 Rifle or their commercial equivalent. CMP Rule 6.0

**Scoring:** All scoring will be in ink, scorecards will be correct and complete before submitted.

**Judges:** Judges will be named at the beginning of the match, decision of the judges is final. Judges reserve the right to weigh medallists' triggers.

**Competitors** are expected to be familiar with the contents of the match bulletin, CMP, and NRA rule books. **Failure to comply may result in disqualification.**

Required: all competitors to comply with CMP eligibility requirements including the requirement to provide a notarized **CMP Eligibility Affidavit and Liability Agreement** (Note: Any competitor having previously signed an eligibility agreement does not have to provide another agreement.).
