# **RANGE RULE REMINDER OF THE MONTH**

Many times throughout the Range Rules, 17 times in fact, there is a distinct callout to avoid striking, avoid hitting, not to shoot (you get the idea), the side-berms on every range at River Bend.

It can be confusing when driving by a match or observing a stage being run by a shooter, that some target are set so close to the side berm -you can't help but to shoot the side berm. Other times, the course of fire (CoF), are laid out in such a way that to score well, a shooter must shoot into the side berm.

I understand how that can be misleading. "I saw it happening, it happened more than once". "The rules must have changed somehow, so now you can shoot the side berms". No, the rules have not changed and... No, you are not allowed to shoot the side berms... as an individual member.

### 1.6 - Club Matches

"RBGC has a very active match schedule on almost every weekend of the month. The match schedule is posted on the RBGC web site. Scheduled matches take precedence over all other activities ... "

3 The examples above were characterizations of match participants shooting during one of the many matches held at River Bend. The underlined portion of Range Rule 1.6 means that during a scheduled match [and \*only\* during a scheduled match], individual-member Range Rules are held aside so that the match is both challenging in its CoF, and safe with the number of Range Officers and Match officials present to maintain safety. Once the match is over and teardown has been completed, the individual-member Range Rule set resumes control over the range and bays used during the match. A scheduled practice session with your friends does not qualify to set aside the individual member Range Rule set for any reason.

As always, the CRO Team is here to be your resource. Flag down the bright yellow/safety-yellow shirt and vests you see for any questions you might have.

# **USCCA Training Update**

### Hello RBGC Members,

We have had good response to the USCCA Training Curriculum now being offered at River Bend Gun Club. We are offering the **Concealed Carry and Home Defense Fundamentals** course in six two-hour segments on the first Wednesday evening of the month from 6:00 to 8:00 pm. This offers you the opportunity to pick and choose what chapters you want to attend. Also if you miss one of the classes you can make it up in the second half of the year. We understand how difficult it is to cut out time for training and this is a great way to complete this course without having to take two days off to do it.

We also have two other offerings beginning the end of March. The **Defensive Shooting Fundamentals (DSF)** and the **AR-15 Fundamentals.** The **DSF** course teaches the use of a handgun for personal defense utilizing how the body reacts naturally in a high stress situation. The **AR-15 Fundamentals** course teaches the foundation of using the AR-15 platform for personal defense. These two courses are one day courses all on the range under live fire.

Whether you are brand new to firearms or you are a experienced shooter, we have a training curriculum that can help you become more proficient in the use of firearms. No longer are firearms training a one size fits all process. We can also offer one on one training for the experienced shooter wanting to advance his skill sets.

We have also scheduled certification of more instructors to help with live fire training here at the club so we can meet the demand. 

# Assistant Chief Range Officer (ACRO)



River Bend members, join me in congratulating Jeff Fegreus on his promotion to Assistant Chief Range Officer (ACRO) from his previous position, ACRO II. It was not that long ago when Jeff decided to give back to the Club that had re-ignited his zeal for teaching life-safety and instruction with firearms and self-defense. Jeff's journey with River Bend began in June of 2018. It wasn't until the 2021 Young Shooters Challenge, where he provided Paramedic overwatch services, that he and I began a conversation of what more was available to contribute to the Club, to the family of like-mind enthusiasts he had met at River Bend.

I reached out to Jeff in December of 2021 when the ACRO II ranks opened up to cover the safety needs of the many ranges and members with guests at the club. It was the middle of Covid-19; being indoors was un-healthy and masks were

everywhere. Outdoor activities were mask-free and the place to be to keep clear of disease –the Club was busy! After 3+ years, the member Jeff Fegreus, joined the CRO Team on 28 December 2021 as the latest ACRO II at River Bend. No one had any idea of the warp speed with which Jeff approached 2022 from Day 1.

As a nationally registered Paramedic Instructor, Jeff instituted the "Stop The Bleed" class for the members. Worldclass combat trauma treatment in our backyard –free to members! Including the checkbox for the American Heart Association's CPR course; any member was empowered to help the injured and protect the Club's safety record. Jeff's desire to 'serve and protect' is more than a clique –it is his lifestyle. From his teenage years in Key Largo fishing and diving, salt-water soaked his veins and led to service in the US Navy -protecting American freedom around the Globe. He parlayed his Military acumen into the Public sector as a Deputy-Sheriff in service to the Columbus Georgia area before migrating toward N. Georgia in search of the retired lifestyle.

Jeff, his wife Mary, and Onyx (German Sheppard) settled in NW Georgia to begin living the retired life when River Bend Gun Club took his fire for 'doing right' and spread it over the ranges and bays from Silhouette to Plinking Range. In order for River Bend Gun Club to continue to function as a premier shooting facility for club members, the club needs well qualified, dedicated members to handle the management and administrative tasks necessary to ensure the club serves the needs of its members and runs smoothly.

The ACM position pays \$18.00 an hour, the hours are flexible and there are opportunities for advancement. The ACM position is not a work from home situation and it does require the employee to be at the club during working hours. Please contact me if you are interested. River Bend Gun Club is seeking qualified candidates for the Assistant Club Manager position. The current Assistant Club Manager is retiring in June of 2023. In order to meet training needs and to support near term staff augmentation requirements, the club would like to fill this position as soon as feasible.

#### Job Description

The Assistant Club Manager (ACM) assists the Club Manager in day-to-day operations; however, the primary role is one of membership support and lifecycle management of membership. In this role the ACM reports directly to the Club Manager and coordinates with the CRO team, Club Secretary, Treasurer, Membership Communications Manager, Range Officers, staff, members, and vendors as needed.

This is a full-time position requiring at least 40 hours per week with the requirement to be onsite at least one weekend day per month in support of New Member Orientation (NMO). Additional weekend support may be needed for special events such as the annual Young Shooters Challenge (YSC) or the Annual Business Meeting and Picnic.

Candidates must be an RBGC member in good standing for at least three years and must possess excellent interpersonal, verbal, and written communication skills. Administrative and organizational skills are essential. A basic working knowledge of MS Excel and MS Word is desirable as are any data management skills.

#### **Primary Responsibilities**

The ACM is responsible for lifecycle management and support of membership including initial membership inquiries and maintenance of complete and accurate records and archives of membership throughout the life of same. These responsibilities include:

- •Acting as the primary point of contact for membership inquiries, facility tours, and membership applications
- •Managing membership intake processes, vetting of applications for membership, scheduling of applicants into NMO and post-NMO processing of applicants into membership
- •Administration of membership pricing, invoicing, system configuration updates, changes, and reporting as needed
- •Updating and managing membership records throughout the lifecycle of membership. Support and resolution of membership related questions or issues for existing members
- •Development, coordination, and implementation of the annual membership renewal
- •Issuance of membership / staff badges and gate card credentials
- •Managing the gate access system, gate credentials, and gate schedules.

- Accounts Receivables, banking, and deposit reporting
- Employee onboarding processes
- Vendor management

## **Official Club Business**

#### Highlights of the January 9, 2023 Board of Directors Meeting

President Will Owensby presided over a quorum of six Board members. Also attending were the Assistant Club Manager, four club officers, one life member, and two annual members. The meeting was convened at 7:00PM on Monday, January 9, 2023. The meeting was held at RBGC's Gene Mowell Conference Center on club property.

A quorum was confirmed, the proposed agenda was adopted, the minutes of the November 14, 2022, Board meeting were approved, and the following officer and manager reports were presented and accepted:

Treasurer Secretary Chief Range Officer Club Manager Shotgun Manager

Board decisions made, actions taken, and items of interest:

- Treasurer Geoff Rhines presented the Treasurer's report and reported that December FYTD income was \$766K, a decrease of approximately \$26K versus the same period in FY 2021.
- December FYTD expense was \$523K, a decrease of approximately \$96K versus the same period in FY 2021.
- Cash in the bank as of 12/31/22 was \$448,356 including \$100,221 in Capital Reserve Fund and \$42,361 in Scholarship Fund.
- Club Secretary Erica D'Amico reported that the membership total at the beginning of the January 2023 meeting was 2,250; 78 members more than this time last year.
- The number of Senior Members at the beginning of the January 2023 meeting was 205; 9.11% of RBGC membership and 9 members more than this time last year.
- There were 9 members on the Life Membership Wait List at the beginning of the January 2023 meeting.
- Chief Range Officer James Garner reported that the Range Use Summary Report for December 2022 totaled 1,623 (1,326 members and 297 guests).
- Total Range Use Summary for 2022 is 22,325, which is a decrease of less than 1% from 2021.
- Ten venues submitted Match Use Summary Reports for December 2022. Total entries were 190 (91 members, 96 nonmembers, and 3 juniors). December match income was \$2,909.36 with \$510.00 reported to the club.
- Total Match Use Summary for 2022 is 176 matches with 5,185 competitors, 339 more than 2021 (2,302 were members, 292 more than 2021; 128 were juniors, 61 less than 2021; and 2,776 were non-members, 398 more than 2021).
- There were 8 Tac Rifle Certifications, 2 NFA Certifications, 0 Supergun Certifications, and 0 Stop the Bleed Certifications in December 2022.
- Greg Hughes presented the Club Manager's report and reported that repairs have been made to the 500-yd gong on SL Range.
- Target reset chain and first aid kit were replaced on CG Plinking Range.
- Shotgun Hill Manager Bill Wettingfeld reported that shotgun range use in December 2022 was 292 shooters (250 members and 42 guests). 906 rounds were fired during December with 15 cart rentals. Total December revenue to the club was \$7,090.00.
- Member Communications Manager David Norcross reported that the January 2023 Bullet-IN reached 2,327 recipients with 2,323 successful deliveries (99.8%). Open rate was 1,623 (69.7%) and 665 (41.0%) members clicked through the newsletter.
- The Board approved 14 new members and 1 reinstatement.
- The Board Application Review Committee (BARC) was formed. Life Member Bill Illg was approved as Chairman, and the committee members were selected: Life Member Bill Goode, Life Member Bobby Reiber, Annual Member David Norcross, and Annual Member Greg Hughes.
- Infrastructure Member Greg Hughes reported that the neutral/ground wire between power pole and Shotgun Hill Clubhouse is being replaced.

- Faulty switches and timers for Cold Range Lights on the SL range have been replaced. Lights are working properly.
- Range Rules Revision Committee Chairman Jim Garner reported that the updated 2023 Range Rules have been uploaded to the RBGC website and 100 copies have been printed.

Regular monthly Board meetings are called to order at 7:00 PM on the second Monday of each month in the Gene Mowell Conference Center. RBGC members and families are cordially invited to attend.

Due to our country's legal environment, your receipt of this article and any use you make of the information in this article are subject in every respect to the limitations and conditions language at the end of the article.

Chapter 3 pretty-much stated in words of one syllable that accurate ammunition is consistent ammunition, with the objective of producing a consistent pulse in the system. I believe the foundation for that consistent pulse is consistent brass, the boiler room in which the pulse is produced. This article and articles for the foreseeable future will present means and methods for preparing and maintaining rifle brass for that purpose.

Annealing brass falls under the heading of brass maintenance. Brass work hardens. That means its physical properties change when it is subjected to repeated deformation. It becomes less malleable, meaning progressively increasing stress is required to change its shape.

In the case of rifle brass, work hardening increases the difficulty in resizing it with a resizing die to the point where it will no longer deform to allow easy chambering. (More on this topic in subsequent articles.) Work hardening also alters the ability of the case neck to consistently grip the bullet with the same stress (neck tension variation). Such variable brass properties produce variable pulse, and groups open up accordingly.

Annealing is simply a process that applies a strategic temperature to the brass that causes it to essentially revert back to its as-manufactured (new brass) physical properties. In this case, "strategic temperature" is 650 to 660 degrees F. Bringing the temperature of the neck and shoulder area to this temperature, then immediately quenching (cooling) it in water is the annealing process that I will subsequently describe.

Bottom Line: Periodically annealing your rifle brass is fundamental to achieving a stipulated accuracy goal more stringent than minute of deer. Regardless, the accuracy you think you have achieved without annealing will deteriorate with each subsequent resizing/firing.

The simple way to anneal brass is to act like big government: throw money at it and buy a specialized brass-annealing carrousel. Those of you who shoot matches that require using a bodacious quantity of brass may very well decide such an approach is preferred to the one I will subsequently describe. Annealing rifle brass with a carrousel-style device is way faster and produces more consistently-annealed brass. As Forrest would say: "That's all I'm going to say about that".

The annealing method described in this article is the one I used before purchasing a carrousel-style annealer. This method can be characterized as effective, relatively inexpensive, and simple. As implied in the previous paragraph, it is "slow", and could be considered by some to be tedious. There are multiple annealing-method variants of "effective, inexpensive, and simple", and I will not defend nor claim my method is "the best".

Be Advised: You will be officially playing with fire while annealing brass. At a minimum, positively secure the flame source and remove readily combustible materials from the immediate area. The "Limitations and Conditions of Use" section at the end of this article definitely applies. Furthermore, your significant other may or may not have indicated a prior DEFCON level associated with you playing with guns and crafting potential IED's. Discovering that you are now "playing with fire" in proximity of powders and primers may spool up a DEFCON Level 5 with all the attendant visual and sound effects. Jim Hardy's wife would not let him anneal brass inside the house.

The tools and equipment associated with my rifle brass annealing method are identified in Pictures 4-1, 4-2, and 4-3. Picture 4-1 shows the following items:

- Butane torch (tank and nozzle) that serves as the flame source.
- Sacrificial brass required to calibrate the process (you may need more than a couple).
- Variable speed drill (old single-speed electric drill will do just fine).
- Case chuck with appropriate shell holder.
- Case stand for queuing brass to be annealed (shown is an insert removed from an ammo box).
- Gloves to protect the hands from hot brass.

Picture 4-2 shows:

- A Tempilstik rated at 650 degrees F (available at a welding supply shop).
- Emory cloth/sandpaper from 40 to 80 grit required to score/roughen the case shoulder area to enable application of the Tempilstik powder to achieve calibration.
- OOO steel wool to clean the case neck and upper shoulder area of powder soot residue and any oxidized surficial layer prior to calibration/production annealing.

Picture 4-3 shows:

- A 5-gallon bucket that serves as the secondary quenching vessel.
- A convenient-sized container, located a convenient distance from

the flame source, that serves as the primary quenching vessel (sliced deli-ham container shown).

Picture 4-4 shows my shop arrangement of some of the previously identified equipment during the annealing process. Water would be placed in both quenching vessels (primary at least <sup>3</sup>/<sub>4</sub> full; secondary at least <sup>1</sup>/<sub>2</sub> full). Note that the butane torch is positively secured in a wood-working vise. Your method of securing the torch must be improvised, and your actual equipment arrangement will vary accordingly.

The brass to be annealed must be heat calibrated prior to production annealing. During the calibration process, the sacrificial brass must be strategically positioned in the heat-source's flame to determine the time period required to bring the neck and shoulder area to 650 degrees F. This temperature occurs when the Tempilstik powder residue turns to a dark brown color.

The time to a Tempilstik's powder residue color transition is variable, dependent on the brass to be annealed (manufacturer, lot, configuration, etc.) and the characteristics of the heat source, including the actual flame configuration (your flame and heat will likely be different than mine). Any time the brass changes (lot, .223 Rem. to 338 Lapua, etc.) or a new butane source is used, a new calibration is warranted. If the time calibration is in actual seconds (alternatively, it could be determined by counting beats while listening to your favorite song), expect anywhere from 2 to 8 seconds to anneal each piece.

The heat-calibration procedure is as follows:

- Chuck a sacrificial brass case into the drill and polish the upper ½ of the case (neck/shoulder area).
- Circumferentially score approximately ½ inch at the top of the shoulder with the emery cloth/sandpaper.
- Stroke the Tempilstik's contents longitudinally (in line with the case's long axis) at a right angle to the scoring to deposit a powder residue film on the case.
   Picture 4-5 shows a scored case (top) and a scored case with applied Tempilstik
   Picture 4-5 powder residue (bottom).
- Arrange your annealing set-up (Picture 4-4 as an example) so that it includes water in the quenching vessels.
- Spend sufficient time watching a second hand on a watch/clock to comfortably embed a one-second cadence. A metronome works swell. Otherwise, turn on your favorite song.
- Open the torch nozzle's valve all the way (an indeterminant, partial opening will be a source of variable heat the next time you anneal, requiring a new calibration).
- Ignite the torch's flame.
- Chuck the sacrificial calibration brass with the applied Tempilstik residue into the drill so that it is oriented for you to clearly see the powder residue.
- Quickly position the calibration brass in the flame so that the transition between Picture 4-6
  its shoulder and neck is right at the tip of the large interior flame (the flame
  within the flame). When the brass is "there", begin the count. Picture 4-6 identifies the location on the case where
  the flame tip should be positioned. Picture 4-7 is my best attempt to photograph the location of the flame tip I'm
  trying to describe: in the picture it is to the right of the brass nozzle, at a distance approximately equal to the length
  of the solid brass tip beyond the air-vent holes. The general orientation of the case relative to the torch is shown in
  Picture 4-1.
- Do NOT spin the brass. You need to see the powder residue to identify the count at which it turns brown. (Spinning the brass will occur during production annealing.)
- Mentally note the count at which the Tempilstik powder residue turns brown. That is the time (or count) that will be required to anneal each subsequent case.
- With the case still fastened in the chuck, immediately dunk its upper shoulder into the water contained in the primary quenching vessel.
- With a gloved hand, unchuck the case and allow it to fall into the secondary quenching vessel (it will right itself and be "standing up" on the bottom).

I suggest doing at least one confirming calibration with a different brass case. Be sure of the calibration count. Furthermore, the case must be perfectly dry before priming and loading. Uhhhh.... appropriating your significant other's hair dryer without permission is NOT a good idea....

The Tempilstik powder residue will obviously turn brown while the case is in the flame; there is nothing subtle about the color transition. Picture 4-8 is a good-faith effort to depict a "before" (top case) and "after" (bottom case) comparison showing the powder's color after annealing. As is apparent in the lower case, the only portion that remains brown is in the scored "valleys" of the brass.

Depending on the degree of oxidation on the case surface, other colors will show up. The limits of the annealing can be identified by a narrow, circumferential silver/lightblue hue band transitioning to some shade of violet. Picture 4-9 shows this narrow band. The pencil tip identifies the base of the band/limit of annealing.

The lower limit of this band should really be no lower than about ½ the case length. If it is visually lower, recalibrate the annealing process by placing the flame at the juncture of the neck and shoulder (Picture 4-10).



The procedure for production annealing is the same as presented above, except the shoulder of the case is not scored and you should spin the case to better distribute the heat.

The annealing frequency is your choice. The 1000-yard benchrest bunch I hung with had a rule of thumb that the brass should be annealed after its third firing. That sequence is: fire-resize-fire-resize-fire-anneal. Because I have a carrousel-style annealer, I anneal after every firing.

As implied in the above sequence, annealing should be performed **prior** to resizing and trimming the brass. Hmmm....I wonder what the next Bench Tech articles will be about?


